TOWN OF HARWINTON ORDINANCE AMENDING LAND USE APPLICATION FEES

SECTION 1. AUTHORIZATION: Pursuant to Connecticut General Statutes, §8-1c, as amended, the Town of Harwinton amends Ordinance No. 82, adopted March 6, 1990, as amended by Ordinance No. 99, adopted May 19, 1998, as amended by Ordinance No. 102, adopted September 26, 2000, to amend its land use application fees schedule to cover the reasonable cost of administrative processing, technical review, zoning enforcement, legal notices and publication required for various land use applications and to defray the reasonable cost for on-site inspections to ensure compliance with its municipal land use regulations.

SECTION 2. PURPOSE: The purpose of this Ordinance is to: (a) provide that the reasonable cost of review and processing of applications and inspections of sites are paid by the applicant and (b) to ensure post-approval compliance with municipal land use regulations and conditions of approval through adequate on-site inspections.

SECTION 3. BASE APPLICATION FEES: The Planning Commission, Zoning Commission, Zoning Board of Appeals, and Inland Wetlands and Watercourses Commission shall, by regulation, adopt base application fees to cover their reasonable cost of administrative processing, routine review, legal notices and publication. The Town's base application fees shall be as set forth in the current Harwinton Zoning Regulations, Subdivision Regulations, and Inland Wetland and Watercourses Regulations, as may be amended or revised by the respective Commissions. Such fees shall be considered the minimum application fees required for a routine application.

SECTION 4. ENFORCEMENT AND COLLECTION: The filing of an application constitutes the applicant's and the property owner's agreement to pay the base application fee and any additional surcharge fees. The base application fee shall be paid at the time the application is filed. If such fees are not paid when due, the Commission may deny the application as incomplete or withhold the issuance of any permit approved, and commence legal action against the applicant and/or the property owner to recover the fee. In the event the Commission is compelled to retain legal counsel to recover the fee, the applicant and/or the property owner shall be liable for the Commission's reasonable attorney's fee and costs of collection.

SECTION 5. ZONING COMMISSION FEE SCHEDULE: The Fees set forth in the Harwinton Zoning Regulations shall be as follows:

SECTION 6. ZONING BOARD OF APPEALS FEE: The fee for any application or petition to the Zoning Board of Appeals for a variance or appeal or other matter is increased from \$150.00 to \$155.00, plus \$20.00 state fee for a total of \$175.00, nonrefundable, due at the time of filing the application or petition.

SECTION 7. INLAND WETLANDS AND WATERCOURSES COMMISSION FEE SCHEDULE: The fees set forth in the Regulations of the Inland Wetlands and Watercourses Commission (the "Agency") pursuant to Connecticut General Statutes, §8-1c and §22a-42a(e), as amended shall be as follows:

SECTION 19 - APPLICATION FEES

- 19.1 Method of Payment. All fees required by these regulations shall be submitted to the Agency by personal check, certified check or money order payable to the Town of Harwinton at the time the application is filed with the Agency.
- 19.2 No application shall be granted or approved by the Agency unless the correct application fee is paid in full or unless a waiver has been granted by the Agency pursuant to subsection 19.7 of these regulations.
- 19.3 The application fee is not refundable.
- 19.4 Definitions. As used in this section:

"Residential Uses" means activities carried out on property developed for permanent housing or being developed to be occupied by permanent housing.

"Commercial Uses" means activities carried out on property developed for industry, commerce, trade, recreation, or business or being developed to be occupied for such purposes, for profit or nonprofit.

"Other Uses" means activities other than residential uses or commercial uses.

- f. ILLEGAL ACTIVITY in a regulated area is subject to inspection and review fees and expenses at the rate of \$50.00 per hour (or a fraction thereof) in connection with such action.
- g. Pursuant to Ordinance 102 effective 10-12-00, SURCHARGE FEES:
 - a. When the actual cost of processing an application exceeds the base application fee due to the need for outside consultant services, the Planning Commission, Zoning Commission, and Inland Wetlands and Watercourses Commission may charge the applicant an additional surcharge fee to cover the estimated reasonable cost of such consultant services. Any portion of the estimated surcharge fee not expended by the Town on such services shall be refunded to the applicant.
 - b. In addition the Planning Commission, Zoning Commission, and Inland Wetlands and Watercourses Commission may charge the application an additional surcharge fee to cover the actual, reasonable cost of outside consultant services required to review and inspect a project once an approval has been issued in order to ensure compliance with the regulations and conditions of approval.

THERE WILL BE NO FEE FOR CORRECTING TYPOGRAPHICAL ERRORS.

SECTION 8. PLANNING COMMISSION FEE SCHEDULE: The Planning Commission fee schedule shall be as set forth in the Harwinton Subdivision Regulations and prior Ordinances of the Town of Harwinton.

SECTION 9. EFFECTIVE DATE: These fees shall take effect for all applications filed and all matters occurring fifteen (15) days after publication of a summary of this Ordinance pursuant to Connecticut General Statutes, §7-157(b).
