ORDINANCE INCREASING BUILDING, PLANNING, ZONING AND INLAND WETLANDS COMMISSION PERMIT FEES TO PAY FOR USE OF THE "PERMIT*LINK*" SYSTEM

Section 1. Authorization.

This Ordinance is adopted pursuant to Connecticut General Statutes, Sections 8-1c, 22a-42a(e), 29-263 and the Connecticut State Building Code, as revised, and amends the following Harwinton Ordinances:

- (a) Ordinance Concerning Fee Schedule, No. 82 (1990);
- (b) Ordinance Increasing Zoning Board of Appeals Application Fees, No. 99 (1998);
- (c) Ordinance Amending Land Use Application Fees, No. 102 (2000);
- (d) Ordinance Amending Land use Application Fees, No. 114 (2004);
- (e) Ordinance Amending the Inland Wetlands Commission Application Fee Schedule, No. 125 (2008);
- (f) Ordinance Amending the Zoning Commission Application Fee Schedule, No. 126 (2008);
- (g) Ordinance Concerning Building Permit Fees, No. 127 (2008); and
- (h) Ordinance Amending Land Use Permit Fees, No. 131 (2009).

Section 2. Application Fee Schedule Amended.

The following surcharges are added to the following building and land use permit fees (in addition to the state surcharge) under the "PERMITLINK" Services Contract ("PSC") to cover the cost of the town's use of the "PERMITLINK" System under the "PERMITLINK" Services Contract ("PSC") for issuing certain building and land use permits:
